## **DISCRETIONARY FINANCIAL ASSISTANCE TERMS & CONDITIONS**

- Shocking Pink applies for donations from other charitable trusts to subsidise our Financial Assistance programme. If successful, these donated funds may be used to provide for the payment of discretionary grants. Shocking Pink cannot make any guarantees as to the amounts or occasions when these funds may become available.
- To be eligible for Financial Assistance you must be a young woman aged 20-45 and have received a diagnosis of secondary/metastatic breast cancer for which you are in active treatment (undergoing chemotherapy, radiation, surgery) or within 12 months of your last active treatment (undergoing chemotherapy, radiation, surgery).
- Due to quarterly meetings and audit requirements there may be a delay before any financial assistance can be provided.
- Payments provided by Shocking Pink can only be made directly to the service provider or given as vouchers. The only exception is travel booked and purchased for specific events with prior approval from Shocking Pink for this we will reimburse you directly (less any booking or credit card fees) after the event into a bank acct in the applicants name.
- The Trustees of the Shocking Pink Charitable Trust have complete discretion for funding approval.
- Shocking Pink will <u>only</u> provide assistance towards the following:
  - MTA Petrol vouchers
  - Pak n Save, Countdown or New World vouchers
  - Specialist mastectomy bras, swimwear and prosthesis
  - Courses and seminars related to breast cancer (e.g mindful meditation, Gawler cancer retreats, NZ Holistic Cancer Congress).
  - Utility Bills (telephone, electricity, gas) with evidence of outstanding payment.
- Shocking Pink is not able to provide assistance towards:
  - Rent or mortgage payments
  - Credit card, hire purchase, lease or any other finance agreement payments
  - Credit card fees, booking fees, administration fees or late payment fees
- The trustees request that recipients participate in fundraising efforts for Shocking Pink.
- If the details provided on the Financial Assistance Application form change, you must notify the Trustees.
